4. Fee Waiver Criteria (Plant Level Only)

- **Small category companies - No application fee** for all plant level categories
- **Women employees**
Fee waiver shall be applicable across all eight plant-level categories based on the percentage of women employees in the organization w.r.t. total employees, as per the following:

Total Women Employees	Fee Waiver Applicable
15% – 25%	50% Waiver
25.1% – 50%	70% Waiver
Above 50.1%	100% Waiver

- **Differently abled employees - 100% fee waiver** for organizations employing 5% or more differently-abled employees.

6. Process steps

Step 1: Register for the Awards (Select Plant Level or Corporate Level)

From this year applications and category types for plant level and corporate level are different and companies can apply for both by paying applicable fees.

ACMA Members: Direct registration

Non-Members:

- Companies with turnover up to ₹100 Cr or VDA member companies in India (any turnover) can apply without membership
- **Non-Members** can initiate process to become ACMA Member before December 2027 and parallelly they can apply for Awards right now

Step 2: ACMA reviews and approves registration

Step 3: Receive login credentials and fill your Company Profile (one-time)

Step 4: Application is in TWO areas for Plant level and corporate level categories

- Area 1: This is to be filled only once for one or more applications
Common KPIs (5) and Common Questions (5)
- Area 2: This is to be filled separately for each category application
Category specific KPIs (12) and Category specific Questions (4)
- If applicant has won Platinum award in 2025, then the same Plant cannot apply in the same category, but it can apply in any other applicable category.
- Applicant can submit the applications by filling Area 1 (KPIs and Common Questions) and Area 2 (KPIs). You have time till 3 days prior to site assessment to submit Area 2 (Category Specific Questions)

Step 5: Schedule virtual site assessment (select week)

- Receive assessor details and finalize the assessment date from the selected week with Assessor
- Complete Area 2 (Category specific Questions) at least 3 days before the site assessment date
- Prepare your supporting data/ presentations in advance for showing during assessment
- Share virtual meeting link with the Assessor

Step 6: Payment process (if applicable)

- Receive the payment invoice
- Ensure that applicable payment is processed before site assessment date

Step 7: Assessment reports are submitted by ACMA to the Jury

Step 8: Jury evaluation

Step 9: Awards Ceremony on 3rd March 2027, New Delhi

Step 10: Feedback report to applicants

7. Key Notes

- Applications must be submitted through the Digital ACMA Awards System (DAAS)
- All submissions must adhere to timelines; late entries will not be accepted
- Confidentiality of company data will be strictly maintained by ACMA
- Companies, while submitting online applications for ACMA Excellence awards, be certain to furnish all relevant information correctly and as per the best of your knowledge and records.
- The submitted applications will be considered final for further processing.
- Applications submitted online with incomplete, incorrect data & without customer details will not be processed and will be liable to disqualification from participating in the Award process.
- Jury decisions will be final and binding

Note: ACMA reserves all rights to reject award applications in case filled in wrong category or incomplete.
